#### TASCOE Members,

The current financial health of our organization is solid, but please note that a National Convention will put a financial strain on TASCOE and the importance of fundraising and sponsorships should not be understated. It will take hard work of TASCOE members, committees, and our executives to ensure financial stability during planning stages of National Convention.

My past Finance Committee report discussed personal finances and several members and non-members reached out to me with questions and asked for advice. I always state that I am not a CPA or financial consultant, but I do not mind helping folks in any way that I can.

Current inflation rates have made people change or rethink their larger purchases, investing decisions, and reassess their current lifestyles. However, there are a few instances where an investor can take advantage of the situation. Certificate of Deposits (CD) available in various terms that fit your needs are now earning over 4% in most cases and over 5% in some instances. Currently, Money Market Accounts (MMA) that offer a low-risk environment are earning higher interest rates compared to years past.

The Current Year to Date (YTD) returns for all TSP funds are in the black. I encourage you to check your TSP balance regularly and make sure that you have established or updated your beneficiaries. Lastly, educate yourself on the Roth TSP option and determine if it is a good fit for you and your financial goals.



### LEGISLATIVE COMMITTEE REPORT

If you have a personal or working relationship with your elected representative where you live, TASCOE wants to know about it. Reaching out and contacting them is very important to our Association and benefits all our employees. Please contact the Executive Board if you have information to share.

Information received from Southwest Area Legislative Chair shows that Legislative Priorities, Reminders, and Updates are as follows:

**FY 2023 Farm Bill**- NASCOE continue to monitor House & Senate Ag Committee hearings through Spring & Summer 2023. NASCOE Members attended Farm Bill listening sessions which included discussions on staffing in FSA Offices and desire to streamline administration of future farm programs. Monitoring ELAP program and suggestions from membership about policy updates.

**Equity Commission updates**- Equity Commission is scheduled to meet again (June 27-29, 2023) The Legislative Team will continue monitoring upcoming meeting comments and registration.

**HR 82- Social Security Fairness Act**- Windfall Elimination Act (Rep. Garret Graves-R-LA & Rep. Abigail Spanberger-D-VA) reintroduced 1/09/2023, currently 279 co-sponsors.

The Legislative Team continues to watch the following bills: HR 866 Equal COLA Act (Rep. Gerry Connolly-D-VA) reintroduced on 2/8/2023, currently has twenty-six co-sponsors. HR 856 Comprehensive Paid Leave for Federal Employees Act (Rep. Donald Beyer, Jr.- D-VA), introduced on 2/7/2023, has thirty-five co-sponsors. HR 4268 Federal Retirement Fairness Act (Rep. Derek Kilmer-D-WA) Failed during 117th Congress (had 101 sponsors). Not yet re-introduced in 118th Congress. Reclassification of Program Technicians as well as the hiring entry level Grade classifications & criteria for new employees.

### PROGRAMS COMMITTEE REPORT




Texas had a total of 24 submissions as of 05/31/2023, 3 of those submissions are considered closed, which means they have been resolved or we heard back from national office and 2 have been referred to negotiations. The remaining 19 submissions are in a pending status. Programs and Negotiations submissions process is transitioning from a manual process to a digital web-based process. The project is not complete yet as there are a lot of moving parts, but submissions are still being accepted and submitted through the current process. Any outstanding questions will be answered as quickly as possible. We appreciate your patience and understanding during this transition.




