

# LEGISLATIVE CHAIR REPORT

#### Legislative Report by Cris Perez, Chairperson

First off, my email is TASCOELEG@gmail.com for all communications. Some of you all have indicated that you will be forwarding Points of Contact (POC) info with our elected individuals. Please send that info to my TASCOE email.

I want to emphasize that our NASCOE & TASCOE reps are working hard to address the need for more funding & staffing. However, the issue is that Continuing Resolutions (CR) short term funding doesn't address those concerns. Our Congress is currently trying to address foreign aid, national security & border security issues.

With that mindset, the extension of the current Farm Bill leaves the USDA at spending levels equal to FY 2023. The House did propose the same levels of funding for FY 2024 & the Senate proposed 120% increase. However, the current administration is pushing to stay the same as FY 2023. Discussions about the future farm bill and FSA funding are at a standstill but our legislators have been receptive to the needs of FSA field office functions especially because of continued disaster programs.

Please be cautious in how you talk or visit with our elected officials. DO NOT use government equipment to communicate with these individuals and DO NOT do it while working. I suggest that you review the HATCH Act provisions to be on the safe side. Any questions or concerns, please feel free to reach out to me.







**History:** Agricultural Adjustment Administration established under the Agricultural Adjustment Act (48 Stat. 31), May 12, 1933. Reorganized under the Soil Conservation and Domestic Allotment Act (49 Stat. 1148), February 29, 1936. Redesignated the Agricultural Adjustment Agency and consolidated with the Sugar Agency, Federal Crop Insurance Corporation, and Soil Conservation Service into Agricultural Conservation and Adjustment Administration by EO 9069, February 23, 1942. Assigned to Food Production Administration by EO 9280, December 5, 1942; and to Administration of Food Production and Distribution by EO 9322, March 26, 1943, renamed War Food Administration by EO 9334, April 19, 1943. Functions reverted to the Secretary of Agriculture when War Food Administration abolished by EO 9577, June 29, 1945. Subsequently assigned to the Production and Marketing Administration by Secretary's Memorandum 1118, August 18, 1945, as functional successor to Agricultural Adjustment Agency. Designated the CSS by Secretary's Memorandum 1320, suppl. 4, November 2, 1953. Name changed to ASCS, 1961. ASCS established by Secretary's Memorandum 1458, June 5, 1961, in accordance with Reorganization Plan No. 2 of 1953, effective June 4, 1953. Administered agricultural price support, production adjustment, and conservation assistance programs; and international commodity agreements. Abolished by Secretary's Memorandum 1010-1, October 20, 1994, implementing section 226 of the Federal Crop Insurance Reform and Department of Agriculture Reorganization Act of 1994 (108 Stat. 3214), October 13, 1994, with agricultural stabilization programs and the conservation reserve program transferred to newly established Consolidated Farm Service Agency (CFSA); and remaining conservation programs transferred to newly established Natural Resources Conservation Service (see RG 114). CFSA, established by same Secretary's Memorandum, acquired not only ASCS functions, but also the Farm Home Loan program of the Farmers Home Administration (abolished by same Secretary's Memorandum; see RG 96); and supervision of the Federal Crop Insurance Corporation. CFSA redesignated Farm Service Agency without change or organization or functions, January 16, 1996.


