# LEGISLATIVE CHAIR REPORT

Greetings TASCOE leadership, directors & members. The 2023-2024 legislative year saw a lot of political infighting in Congress regarding USDA FSA programs and functions. Our County FSA Office employee footprint has grown in the past fiscal year with our WDC administration really supporting us now that they fully understand the role we have in the rural and agricultural community. Our CO employees received accolades for the service we provided during the COVID years.

We did have some concerns with the Equity Commission hearings and final report. Most of the issues that were finalized were only minor and won't really affect us too bad. The good news is our WDC leadership is being swayed by our NASCOE leadership to continue the County FSA Committee (COC) system. There will ultimately be some minor changes to the CO system but nothing drastic. The only major issue that came up and is being challenged is the Equity Commission suggestion that the DD be the hiring authority for all GS & CO employees in the County Office structure. This would include hiring authority of all CEDs and PTs. NASCOE, NAFED and our PAC are doing everything possible to not allow this because of the issue of favoritism and/or abuse of authority. We are gaining ground on this issue being removed from consideration.

The Farm Bill has become a point of contention on both sides of the aisle. The House version keeps field office staffing and funding the same. The Senate version recommends a slight increase in field office staffing and funding. There is some serious talk that the 2025 Farm Bill will be similar to ARCPLC but raise the crop reference prices. The rest of the Farm Bill discussion is that our current programs such as Price Support, LFP, ELAP, ECP, CRP, etc. remain the same.

Finally, give a large round of applause to our NASCOE leadership for never giving up the fight and since the last PT reclassification in 2001, we now have PA positions from CO-7 to CO-9.

Please continue to send me your political contacts and spreading the word of what TASCOE/NASCOE does for our employees.





# **MEMBERSHIP CHAIR REPORT**

What a year has it been! This has been my first year as Membership Chair and boy have I learned a lot in that short amount of time. # PROGRAMS AND NEGOTIATIONS REPORT

HOWDY! Here are some TASCOE and NASCOE updates regarding our Programs and Negotiations Committee (PNC). Programs is about changing software and forms while Negotiations is about changing policy. As a reminder, in September 2020, the Programs and Negotiations committees were combined into one committee. This has allowed for a more simplified and timely process between programs and negotiations since program submissions are taken from you as submitters, to your area chair and then to the National Chair to be either submitted to Washington, DC (WDC) as a suggestion with a specialist or later negotiated with them.

This exciting process has had some great success come out of it. Here is some news, updates, and past wins within the PNC area of TASCOE/NASCOE:

### **Programs and Negotiations News:**

- The PNC Team went to our nation's capital the week of May 19-24 to get us caught up with our negotiation items. Due to COVID and past years we were able to get through two years' worth of negotiations items and our team DID IT!
  - Our PNC team combined both years had over 30 plus items submitted, negotiated and most were agreed upon or resolution was made with WDC. These decisions will help us all make forward progress from not just our HR needs, Handbook updates but some related to our own safety not just for us but the producers in our offices.
- NASCOE wins in 2024 including:
  - National Notice- PM-3083 County Office Program Technician (PT) Reclassification The long-awaited change from DAFO that determined that the current PT duties were complex and like those represented in the Loan Analyst position and that a reclassification of the PT position was needed.
  - Info. Bulletin (IB) 11123 Resolved Producer Farm Data Report (PFDR) Formatting Issue. Added Tract Physical location (County, State) was added to the PFDR. Tract number and physical location (State, County) are displayed in the same column under "Tract/ Physical Location."
  - Info. Bulletin (IB) 11213 SCIMS Customer Search Updated March 11, 2024 SCIMS updated with default set as "Starts With."
  - National Notice LP 2291 Announcing the FSFL and MAL Grain Bin Safety (GBS)
     Preventive Maintenance and Safety Gear Training in AgLearn.
  - XEROX Printers: Printing without PIV Cards This feature was added or made available for current and future devices/machines.

### **Programs Submission Process:**

The process of submitting an item starts with the NASCOE website. To begin the process, one must visit National Association of FSA County Office Employees (nascoe.org) and submit an idea through the Programs and Negotiations tab using the Online Submission Form. Christa Kraatz and Sara Houin, the National Programs & Negotiations Co-Chairs then get a copy of the submission and forward it to the respective area chair and area executives to research and give feedback. The submitter may be contacted by any of these individuals to receive further information or clarification. Other than that, the submitter name is NOT shared.

If anyone wishes to submit a program submission without their name attached, they may reach out to any of the Programs and Negotiations Committee. Lastly, the item is sent to a national contact with programs, referred to negotiations, or a direct reply is sent to the submitter with a solution or idea.

There are instructions and a flyer available for the Program Submission Process available online and copies can be provided upon request from your TASCOE executive team or the NASCOE PNC team.

As a reminder, your PNC team consists of your SWA chair, Terry Cater. He is doing double duty as your area alt. exec and a member of our PNC team until another area chair can be named. We are extremely grateful for him and his input. Also, the same for our state team, Courtney Decker was our programs chair and had to step down. So, if you know of anyone interested in this exciting process then please let Christa or your TASCOE director or exec know. You won't regret being part of this team and learning about all of our submissions and truly be part of the CHANGE!

# HOW ARE UNIONS FORMED?

Unions are typically formed in response to poor working conditions or low wages and are designed to give workers a collective voice in negotiations with their employers. They negotiate collective bargaining agreements that cover issues such as wages, benefits, and working conditions. Unions are typically run by elected officials and may have paid staff to assist with their operations.



# WHAT IS AN ASSOCIATION?

An Association is a group of individuals or businesses that come together to achieve a common goal, and that goal could be anything within our job. Associations have employees that volunteer time to achieve those many goals. Goals as in better wages, software, and benefits that we may not have had in the past.



# WHAT CAN UNIONS DO?

A Union is an organization that represents workers in collective bargaining with employers, and members of a union have the legal right to engage in collective bargaining with an employer. The employer is also legally obligated to bargain with the union.

## **ASSOCIATIONS CAN'T STRIKE!**

Since June 12, 1962, NASCOE has exclusive rights to represent all county office employees in consultations and negotiations with management of FSA and USDA under the Labor Management Relations Agreement. Employees covered by this agreement do not have any rights to individually or collectively to strike, cease work, or otherwise interfere by concerted action, in any way at any time with the expeditious accomplishment of assigned work.






**Wise County**








## **Dickens and Kent County**


