For a Regular County Office Employee TASCOE dues are 0.35% of your annual salary. For example, if your gross annual salary is \$38,000 you would take $\$38,000 \times .0035 = \133 . This would be the amount withheld per year (which is around \$5.11 per pay period). Of this amount, \$75 is sent to NASCOE for national dues. Dues check-off makes paying dues very simple. If you are not on dues check-off, we encourage you to check it out.

HONORARY LIFETIME MEMBERSHIP

To be eligible for NASCOE/TASCOE Honorary Lifetime Membership, one must have been a regular member since becoming a permanent employee and continuing until retirement or one must have been a regular member since TASCOE was formed and continuing until retirement.
